Referees' reports (three to be submitted)

A request for referee reports will be forwarded automatically (via email) to each of your three nominated referees once your online application is submitted. Please notify your referees and advise them of the application closing date before submitting your online application.

Application for more than one program

You may choose up to three program preferences via the online application form. If you are applying for more than one program eg. Clinical and Organisational you will need to tailor the additional application form to reflect why you would like to undertake each program.

Interviews

Shortlisted applicants are interviewed in November, 2017 for Semester 1, 2018 entry. The School of Psychology will contact shortlisted candidates directly to arrange an individual interview or assessment-based activities for the Master of Organisational Psychology & the Master of Psychology candidates, (eg individual written task, group-based discussion and individual interview). If a domestic applicant is travelling overseas at the time that the interview is scheduled, it is expected that they will arrange access to video-conferencing/Skype facilities via a university or commercial provider in order to take part in the interview. NB: Your application will <u>not</u> be considered if you are unable to attend an interview or arrange for video-conferencing/Skype facilities.

Selection

Applications are assessed using a two-stage process. Firstly, the applicants are shortlisted for interview based on academic achievement, relevant work experience and referee reports. Applicants selected for interview are then assessed by a small team of teaching staff and supervisors within each program. Final selection is based on the application as a whole including academic achievement, relevant work experience, referees' reports and interview (including assessment-based activities for the Master of Organisational Psychology & Master of Psychology candidates).

Offers

Offers are made from late November 2017 for Semester 1, 2018 entry. No deferred enrolments are permitted.

Registration

All successful applicants will receive advice with their offer regarding applying for psychologist registration. You must have provisional/general registration with the Psychology Board of Australia to commence the program.
